**Ref:-** Your letter No.386 Dated. 23-01-2023 and 390 dt.08-03-2023

In above cited subject and referenced letter, directions regarding de-novo allotment procedure on the seats of senior residency/AP/Junior Specialist in Government colleges and RajMES Colleges were seek. In this regard you are directed for following instructions as per related Hon'ble High Court Judgments.

1. All the seats of Senior Residency vacant as on 12.07.2022 and created or vacated after 12.07.2022 till 31.03.2023 will be considered for allotments.
2. All the posts of Assistant Professor of Super-Speciality subjects as on 12.07.2022 and created or vacated after 12.07.2022 till 31.03.2023 will be considered for allotments.
3. All the post of Junior Specialist vacant as on 31.03.2023 will be considered for allotments.
4. 10 % of total seats of Senior Residency will be available for other candidates (M.D./M.S. /D.M./M.Ch. courses candidates of 2018 or earlier batches and candidates of other type of courses like DNB etc.). For assigning inter-se merit, the candidate higher in age will be considered higher in merit.
5. Remaining 90% seats of Senior Residency will be classified on the basis of department wise proportion of the In-Service and Non-Service candidates of 2019 M.D./M.S./D.M. /M.Ch. batch. For assigning inter-se merit for allotment to in-service candidates, the score on the basis of which admission was given in the PG course will be considered. And for Non-service candidates, the merit of NEET PG examination on the basis of which admission was given in PG course will be considered.
6. That the allotment procedure will be first conducted offline on 10% seats available for earlier batches candidates and other candidates. After then allotment procedure on seats available for In-service candidates of 2019 batch will be conducted offline.

7. If any seats remains vacant after the allotment procedure conducted as per above point no. 6 such seats shall be included for allotment procedure conducted to Non-service candidates of 2019 batch. This allotment will be done online.
8. Candidates posted/working joined on the seats/posts that were filled at the level of Medical colleges after 12.07.2022 shall vacate those seats and their services shall be deemed terminated if candidate allotted through this allotment procedure joins on that seat / post.
9. Other directions or procedure laid down in instruction booklet not inconsistent to the above points shall be applied as such.
